Documents to be submitted for the spot allotment process

- 1. Candidates already admitted to an Engineering College under the MCAP allotment.
 - MCAP Data Sheet
 - Admission Slip issued by the college last admitted
 - No Objection Certificate (for all admitted colleges other than govt. engineering colleges/aided engineering colleges/govt. co-shared engineering colleges like CAPE, IHRD, SCTCE etc.)
- 2. Other Candidates
 - MCAP Data Sheet
 - If studying in an institution, a Possession Certificate issued by the institution mentioning the list of the certificates in their possession & No Objection Certificate (both in original or by mail to the Principal, MACE from the head of the institution) and all the remaining certificates in original
 - If not studying in any institution, all original certificates are mentioned below.
 - Candidates who cannot attend the allotment process in person due to unavoidable personal exigencies can authorize a representative to attend the allotment process on his/her behalf. Such representatives should submit an authorization letter in the prescribed format. No other format will be acceptable. [See "annexure K" in MCAP Prospectus 2022]
- ➤ Fees The admitted candidates should remit the fee of Rs.29,680/- for General Merit, Rs.13,250/- for SC/ST students at the institute on the same day (If fees remitted to DTE, balance fees need to be paid at the time of admission). [Tuition Fees, Admission Fees, Special Fees, Caution Deposit, University Affiliation Fees, University Administration Fees, University Arts & Sports Fees, University Examination Fees, PTA, Alumni, etc.]
- > Those who got allotment in the spot should take admission to the college on or before 4 pm on 25-11-2022 with the following certificates in original. No further extension for joining will be given under any circumstances.
 - 1. **10**th **Certificate** for verifying Name, Address & Date of Birth. If the Date of Birth is not included in the 10th Certificate, produce another Document like Birth Certificate, etc.
 - 2. Allotment Memo issued by College.

- 3. To prove the **date of birth** (SSLC Certificate or Birth Certificate).
- 4. Originals of **Degree Certificate and Consolidated Mark list** of all parts of the qualifying exam.
 - The candidates should have studied the undergraduate course in an institution approved by the AICTE/UGC approved Universities/Deemed Universities in India. In the case of under graduation from a foreign university in an appropriate area, in which an equivalency certificate was issued from APJ Abdul Kalam Technological University or any other University within Kerala offering engineering/architecture/planning undergraduate programmes.
 - Candidates should have a minimum of 60% aggregate marks in the qualifying examination.
 - For SEBC/OEC candidates a minimum of 55% aggregate marks in the qualifying examination.
 - For SC/ST candidates a pass in the qualifying examination course is sufficient.
 - In the case of Degree Certificate/Mark List in which aggregate marks are recorded in SGPA/CGPA only, without stating the formula for conversion to percentage marks, the criteria prescribed by APJ Abdul Kalam Technological University for conversion of SGPA/CGPA to percentage marks will be adopted.
 - Conversion of GPA to Percentage
 - KTU follows a grading system for awarding grades and grade points to students as
 followed by most Universities. It follows 10 point grade scale. SGPA and CGPA are
 calculated as the weighted average of grade points multiplied by the credits for the
 courses. A general formula for the conversion of SGPA/CGPA into the percentage
 of marks cannot be defined.
 - The Percentage Marks (% Marks) = 10xG 3.75 Where G is SGPA or CGPA
- 5. **Eligibility Certificate** The candidates should have studied the undergraduate course in an institution approved by the AICTE/UGC approved Universities/Deemed Universities in India. In the case of under graduation from a foreign university in an appropriate area, in which an equivalency certificate was issued from APJ Abdul Kalam Technological University or any other University within Kerala offering engineering/ architecture/ planning undergraduate programmes.
- 6. Valid **GATE Score Card** (if not uploaded/submitted, the candidate will be considered for as non-GATE and considered only for vacancies coming after GATE score holder).
- 7. **Transfer Certificate** from the institution where the candidate studied last.
- 8. **Conduct Certificate** (issued after 1st April 2022)
- 9. **Nativity** of the candidate (from Village Officer or competent authority) or True copy of the Birth Certificate issued by the competent authority/passport/school certificate showing the place of birth.
- 10. Valid **Non-Creamy Layer certificate** for communal reservation seat belonging to Ezhava (EZ), Muslim (MU), Other Backward Hindus (BH), Latin Catholic & Anglo Indians (LC), Dheevara and related communities (DV), Viswakarma and related communities (VK), Kusavan and related communities (KN), Other Backward Christian (BX) and Kudumbi communities (KU).

- 11. Valid **Community Certificate** from Tahsildar for SC/ST reservation.
- 12. For **Fee concession to OEC category** certificate to prove community. certificate to prove community and Income certificate (up to Rs.6 lakhs) is required from Village Officer (below One year).
- 13. **Fee concession to children of Fishermen** certificate from Fisheries Officer concerned of Kerala Fishermen Welfare Fund Board.
- 14. Fee concession to inmates of **Sri Chitra Home**, **Nirbhaya Home & Juvenile Home** certificate from Director, Women and Child development.
- 15. **PD Quota** Certificate from Medical Board.
- 16. **EWS quota** Only for the forward community having an income, not above 4 lakh or should produce AAY/PHH certificate.
- 17. **Passport-size photograph** of the candidate -1 No.
- 18. Applicant who is employed or a trainee in Government service, Scheduled Bank, etc. should produce, at the time of the interview, a relieving order and a certificate of good conduct from the Head of the office where the applicant is employed.
- 19. The student who qualifies from other universities should produce a migration certificate at the time of admission.
